- A. The Ministry of sports and hunting of the Cabildo de Fuerteventura and Cycling Club Jacomar Fuerteventura (organization from this moment) organizes the II edition of the FUERTEVENTURA MTB CYCLIST, which consists of two stages.
- B. The race will be 7th y 8th of June 2014. C. Depasture point will be Centro Náutico Insular in Puerto del Rosario at 09:30 h
- D. It is a race included in the calendar of the Canarian Federation of Cycling.

Artículo 2. LEGISLATION AND RULES

A. La CICLOTURISTA MTB FUERTEVENTURA is a cycling "race" of those established in article 9 of the regulation of Cicloturismo-Ciclismo for all of the Royal Spanish Federation of cycling (RFEC) within the framework of a cycling specialty that sees this sport as an exercise physical with a purpose of leisure and tourism or cultural, excluding competition. The cicloturista shall be subject to the provisions of articles 15 et seq. of annex II of the Royal Decree 14282003, of 21 November, which approves the General Regulation of circulation for the implementation and development of the text articulated from the law on traffic, circulation of vehicles Motor-road safety, approved by Royal Legislative Decree 3391990, March 2.







B.Minimum age to participate is 15. to be fulfilled by the cyclist during the current year.

- C. The ciloturista has a non-competitive character. Traffic will be open, forcing participants to respect Road Safety Act and the highway code in force.
- D. Meeting the data protection act is informed that the character data asked will be incorporated in a file owned by the Organization of the event in order to maintain communications with respect to other events. If you don't want to keep your data, you should reflect on the registration form.
- E. The acceptance of this regulation involves mandatory that the participant authorizes to the organizers of the cicloturista to the total or partial recording of their participation in the same, gives his agreement so that his image can be used for the promotion and dissemination of the image of the cicloturista in all its forms (radio, press, video, photo, DVD, internet, posters, media, etc) and gives all the rights relating to their commercial and advertising exploitation that see fit to run, not entitled for its part to receive economic compensation.
- F. The organizer guarantees full compliance with regulations of Protection of data of a Personal nature and, thus, in accordance with the organic law 151999, the participant is informed and consents to the incorporation of their data to the existing automated files by the organizers and the treatment thereof for use in relation to the implementation of administrative, commercial efforts and other activities.







G. The participant agrees that his data can be transferred exclusively for activities necessary for the proper implementation of the management and internal administration of the organizers. Also, participant agrees that organizers direct them information about news, procedures or services that affect to the woman. Acceptance of the participant so that your data can be treated or transferred in the form of this paragraph, is revocable, without retroactive effect, as they have articles 6 and 11 of the organic law 151999 on December 13.

Artículo 3.REGISTRATION AND PRICES

- A. Registrations will be made through the website: www.ccjacomar.es
- B. Deadlines for the registration:
- B.1.- For those who carry out the route complete (7 and 8 June), the registration period will be:
 - From 3 of march till 20 of april 2014.
 - 25 € Federated.
 - 45* € Not federated.
 - ♣ From April 21 to May 11, 2014.
 - 35 € Federated.
 - 55* € Not federated.
- B.2.-For those who only participate in any section of the route (the day







7 or 8 June), the registration, provided that the capacity (250), has not been covered will be 12-31 May 2014:

- 15 € Federated.
- 25* € Not federated.
- * Federal insurance costs €10 per day and person included in the price indicated.
- C.-Places are limited, in strict order of registration: 250
- D.- 25 of the total proceeds will be donated to the Fuerteventura Association against Cancer.
- E.- Participants must present the following documentation:
 - E.1.- Cyclists that are federated in any Federation subject to the UCI.:
 - Fill in registration (annex I).
 - Photocopy of the current year federal card
 - Photocopy of the Identity card.
 - Photocopy of the entry of the registration
 - E.2.- Cyclists who are not federated
 - Fill in registration (annex I)
 - Photocopy of the Identity card Photocopy of the entry of the registration
 - E.3.- Cyclists under age (15 years of age either to meet them during the current year), in addition to the documentation required in paragraphs 1.1. or 1.2. of this regulation, they must submit the authorization paternamaternatutor. (Annex II)

Note: The organization may require, at any time, the presentation of the documentation reviewed.







F.- Registration entitles the rider to take part in the cycle, as well as the race number, the refreshments and the use of the services offered by the Organizer.

Artículo 4. LICENCES

- A. To participate in the cycle it is obligatory to be Federated with a licence valid for the current year and issued by the RFEC, FCC, or the ICU in the case of foreigners.
- B. If you have no license, you must subscribe obligatory a licence-insuance of one or two day, valid exclusively for the days of the cyclist. For the 2014 season, the added cost of this insurance is 10 EUR to be paid at the time of the registration. The day of the cicloturista, along with the race number, delivered a proof of this insurance that the competitor must wear at all times.

Artículo 5. RETURNS AND ANTI-ASSIGNMENT OF INSCRIPTIONS

- A. The inscriptions are considered as definitive once the organization assigned its race number. There is the possibility of return of the registration should not take part in the cycle or in the event of suspension of the woman by Decree of Orange due to weather (heat, wind, etc) of the Government of the Canary Islands. The organization is exempt from the consequences that may be caused to the participants.
 - B. The inscriptions are personal and non-transferable and cannot be used by a person other than the registered. The substitution of one participant on the other is not possible. In case of this fact, the Organizer will automatically eject the participant.







Artículo 6. COLLECTION OF RACE NUMBERS

- A. Collection of rrace numbers will be at the nautical island centre the day of the cicloturista from 07:30 hours until half an hour before departure.
- B. The Organization shall grant race number that is personal and non-transferable and it must be visible at all times for identification of each participant throughout the test.
- C. To pick up the Ridge, the identification by the participant will be essential. Therefore, it will be mandatory to the presentation of an identity document (identity card, driving licence, passport) and the federal license in progress if you have it. At the time of registration or by picking up the race number, must accept the Declaration of the cyclist that informs the risks involved participation and that excludes the organizer's responsibilities in the event of any incident derived from the participation in the March.
- D. To pick up the race number to a third party, it will be necessary to carry a photocopy of the identity document and the federal license as well as a collection signed by the interested party authorization.
- E. In no case will be delivered numbers that do not correspond with the interested person. The resale of rights registration and subsequent involvement with the race number fin of another person can have penalties as much by the seller as buyer and the possibility of action against the two.







Artículo 7. PROVISIONIN POINTS

- A. During the course of the first day shall be the followings provisioning points
 - 1. Liquid: Fuente de la Tababaire (Km)
 - 2. Solid/Liquid: Plaza Nuestra Señora de la Candelaria-La Oliva (Km)
 - 3. Solid/Liquid: Plaza de la Caridad (Km)
- B. During the course of the second day shall be the followings provisioning points:
 - 1. Liquid: Plaza de la Iglesia del Matorral (Km)
 - 2. Solid/Liquid: Alberque de Pozo Negro (Km)
- C. At the end of the Cicloturistait will be a meal for all participants.
- D. Participants must deposit the wastes in the areas designated for this in the provisioning points. Littering outside these areas will be penalized.
 - E. Organizer won't victualling riders that are not identified as participants in the cicloturista.

Artículo 8: CICLOTURISTA SERVICES

A. There will be a properly signposted car park area next to the Centro Náutico Insular.







- B. Before the Ciclotuirista, in the race number picking up area, there will be toilets and changing rooms properly signposted.
- C. The provisioning at the established points (liquid or fruit).
- D. Bed, breakfast and dinner at Albergue de Tefía (80places in bunk beds, mattresses in 20 and 50 in tatami). The accommodation spaces are limited and will be established by rigorous order of application. It is necessary that each participant bring your sleeping bag or sheets.
- E. Luggage transportation: on the distribution of raceumbers I It will deliver a sticker or bracelet to place in your luggage and make possible their recognition. The organization is not responsible for the loss of personal belongings or those backpacks that are not properly identified. Everything should be on the inside of the bags. The luggage will be moved from the starting point of the day until the end of the same point.
- F. At the end of the cycle, the participants shall be available toilets, changing rooms, showers, transport of return (Las Playitas to the island water sports centre in Puerto del Rosario) and final meal.

Artículo 9: PROTECTION AND ASSISTANCE

- A. There will be presence of vehicles and Civil defence personnel or Red Cross, Guardia Civil and Local Police
- B. Will also attend other vehicles and personnel of the organization Organización(broom car, assistance, etc.)







- C. It will provide mechanical support for failure of consideration. Labor will be free, but the price of the installed material will be borne by the cyclist.
- D. Organizers also will put signs, signs, arrows and volunteer staff in the places which creates suitable and or possible. Means that they are merely informative aid and not a mandatory condition. Therefore, the cyclist exonerates the organizers of the elements that have not been well placed and declines to carry out any legal action against the organisers.
- E. I authorize medical services event, to which any cure you might need while I practice or not in a position to apply, pledging me to abandon the woman if they consider them necessary for the good of my health.
- F. That I release the organizers of any prejudice that may arise from my participation in this event, taking the existing risk to health posed by the physical effort required for participation in this event for health reasons.

Artículo 10: OBLIGATIONS OF THE PARTICIPANT

A.Participants should know riding perfectly.

- B. May take part all those over 15 years either complying with them during the current year
- C. The cyclist should carry race number and or clearly visible identification plate







- D. Be free from any physical defect or disease preventing him to perform such activity
- E. Experience in M.T.B of more than 50 km routes
- F. All models of bicycles must be series production and take print, in a visible place, name of manufacturer, model or brand of manufacturing.

GThe use of the helmet is mandatory during the evento. The organizacion guard reserves the right to expel from the event to anyone that will not lead.

- H. Two wheel cameras and hand pump.
- I. Gloves
- J. Chain repairing set.
- K. The material needed to repair a puncture or replace a wheelcamera
- L.

 They shall respect and comply with traffic rules as well as the road safety law and the existing highway code. The participant acknowledges being informed that the firm of highways and roads may have deficiencies, narrow areas, declines and dangerous curves, so organizers ask you to exercise caution and the participant exempts the organizers for any incident or accident resulting from their participation in the cicloturista.







M.Respect for the environment and nature, not littering or packaging of food, Leave the footprint of the wheel of the bike only, please.

- N. Solidarity with the Group and respect for the norms of coexistence and circulation (avoid inopportune overtaking, respect safety distances, not pushing, etc).
- O. It is obligatory to help another cyclist, who is in difficulties or in the event of a fall.
- P. For security reasons, participants must be the controlled by signatures, both the departure and arrival.
- Q. It is not allowed to towing or assistance from outside Organizer vehicles.
- R. The Organization will set the distance between the head and tail of the group. Any cyclist may exceed the Organization marking the head and pace of the group, or staying behind the Group's closure.
- S. The rider must accept the document declaration of the cyclist that informs the risks involved participation and that excludes the organizer's responsibilities in the event of any incident or accident resulting from participation in the test.
- T. The participant, by enrolling in the cicloturista, accept all you points of this regulation. The breach by the participant of any of the rules above will mean his automatic disgualification.







- U. I release the organizers, any natural or legal person linked to the Organization of the event, of the responsibilities arising from any accident not related to the event caused both by reason of circulation and sporting accidents.
- V. That I release the organizers of any liability arising from participation in the event such as loss or damage to personal belongings, by theft, loss, or other circumstances.
- W.Abide by any standard and relevant guidance that this organization deems appropriate for the optimal development of the routes.
- X. Abide by the rules and guidelines of the relevant organizers to the optimum development of the event

Artículo 11:RIGHTS OF THE ORGANIZATION

- A. The organizers reserves the right to modify issues relating to the location of the refreshments, travel, etc. when there are grounds justifying these changes, informing them to all participants of the cicloturista.
- B. The test Committee will be formed by:

- C. At any time, the organizers reserve the right to neutralize the March and resolve it, at its discretion, due to any incident that may occur in the course
- D. The organizers are not liable of any kind of accident that could be the victim or cause the participant, as well as possible debts that can collapse during the cycle.
- E. The route and establishment of timetables, will be subject to weather conditions and the coordination of the organizers. Where the Canary Islands Government Decree alert Orange due to any weather, the event will be suspended automatically. The organizers will not return the amount of the inscriptions in his power if there is the possibility to postpone the cicloturista to a new date if is permitted by the calendar.
- F. Participant which is removed, except for injury, disease, breakage, etc. between populations or refreshment points, the organizers are exempted from any liability and you can not merge again to return.
- G. Participant which for any reason not to continue the pace of the rearmost group, will assume the relevant indications of the organizers and members of security.
 - H. A negligent and repetitive behavior by a cyclist, organizers may exercise the principle of authority and does not allow him to continue the cicloturista
