INFERNO 2023 - RACE REGULATION

The INFERNO race is a running event with obstacles. The event is structured in one or more running events of between 2 and 14 km in length with the presence of natural and artificial obstacles, on mixed asphalt and dirt or snow-covered terrain, open to all men and women over 16 years of age (from 13 years of age for shorter distances), in possession of regular medical certification (see specifications below).

The map and participant guide are published prior to each event and are to be considered an integral part of these regulations.

Any further limitations or restrictions due to regulations, DPCM decrees or other legal norms with respect to what is stated below will be communicated on the event website and on the relevant social channels.

1. RACE PATHS AND OBSTACLES

The total length of the course may vary for each event and will be announced on the event website. The course will include obstacles, both natural and artificial. The official route map will be published on the website www.infernorun.it In addition to dexterity, climbing, jumping and swimming skills, running speed will also be essential to complete the competition. The course may also include crossing ditches, forests, rough terrain, with wood, logs or roots, wires or ropes, rubble or surface rocks, frozen or snow-covered sections, crossings of rivers, streams, lakes, natural or artificial water holes. The risk of tripping and falling is constant.

The organizers would like to point out that during the crossing of obstacles, as well as on the entire race course, injuries and/or accidents may occur between participants. In addition, dangers can be caused by falls or actions of participants involving other competitors. We therefore recommend that you adapt your pace to the terrain, the visibility conditions, the type of obstacle to be tackled and the crowding of the course section. Each obstacle has its own rule of execution and engagement that must be followed for the safety of all parties involved.

Due to the number of participants, visibility of the course is not always ensured. In this case, participants are forbidden to continue at full speed. It is mandatory to reduce speed to adapt to the terrain and visibility conditions. When approaching each obstacle, the participant must pay close attention to the information signs present and the instructions of the obstacle management staff. More detailed information on the route and its obstacles can be found on the official event website and in the Participants' Guide.

2. RACE, RULES AND DISQUALIFICATIONS

Obstacles are present on the course to test participants. The race is open to competitive and non-competitive participation.

COMPETITIVE RACE - PRO (with sports medical certificate for competitive activity)

Competitive participants will start first in one or more bolge (batteries) reserved for them, will have a race number printed on each wristband and will be equipped with one or more chips for recording their race time. The race management reserves the right to divide or shift the participants (e.g. men and women or the composition of the batteries) if it deems it necessary for organizational or health reasons.

The management reserves the right to vary the times and the bolge (battery) selected during registration if this is functional for the running of the race.





Athletes who are serving a disqualification for doping or are disqualified by the Italian OCR Federation are prohibited from participating in the competitive race.

For participants in the competitive race, obstacles must be overcome correctly and not circumvented, without outside help. Otherwise, the obstacle cannot be considered to have been overcome.

Each competitive athlete is given five (STANDARD RACE) or three (SHORT RACE) wristbands (also known as bands). They must all be worn and are required to enter the starting cage, are personal, carry the bib number and cannot be given away.

EACH ATHLETE WEARS 5 or 3 WRISTBANDS. ON THE SUSPENSION HURDLES ONLY ONE ATTEMPT CAN BE MADE PER HURDLE. EACH OBSTACLE FAILURE RESULTS IN A WRISTBAND BEING CUT.

Before the finish line, the athletes are 'filtered' according to the number of wristbands in their possession:

- with 5 or 3 wristbands they can continue directly to the finish line for the timekeeping
- with O wristbands they can continue directly to the finish line for the timekeeping. They will be listed in the ranking without finish position as DNF but will still be shown the finish time
- with at least 1 wristband must perform the penalty loop (to 1 to 4 times) to replenish the missing wristbands. On successful completion of the test, the athlete may continue to the finish line for the timekeeping.

PENALTY LOOP

- Consists of a running, carrying or strength test or other
- Must be completed a number of times equal to the number of lost wristbands, up to a maximum of 2 or 4
- It is placed near the finish line
- Those who fail the penalty loop test will have all their wristbands removed and after the finish line are considered DNF (did not finish).
- In order to control the passage of athletes on the penalty loop, an electronic control platform can be set up on the course of the penalty loop, which will be kept as proof of passage in addition to the wristbands.

For each failed obstacle, a band is cut, which is retained by the judge as evidence for a possible final check. As one arrives at the finish line with zero bracelets (DNF, did not finish) or with three or five, the final ranking is based on the finishing time and includes only those who have three or five bracelets on their wrist, depending on the race type STANDARD (5 bands) or SHORT (3 bands)

Once the course has been completed and in any case before the start of the race, the race director will announce the time limit beyond which you will not be counted in the ranking.

The race director may make use of a sweeper service (an athlete of the organization who starts last) who 'cleans' the course and closes the competitive race. This system may be replaced or supplemented by time gates indicating a time limit within which to arrive at a certain point on the course or at the finish line.

Competitive athletes are forbidden, under penalty of disqualification, to try the obstacles before the race. It will be the care and responsibility of each competitively-minded participant to ensure that at the finish line the race judge correctly records the number of bracelets with which the race is finished. Each athlete is responsible for his/her own control devices (wristbands and chips), the absence of one or more of these cannot be contested in any way. Immediately after the finish line each competitor must register the number of wristbands with which he/she finished the race.

The course may not be cut; athletes who take advantage of this by shortening the course or avoiding obstacles will be disqualified. An electronic inter-timing platform will be used to provide this real time recording and to check the actual passage. Incognito judges may also run among the athletes to report to the judge at an obstacle or at the end of the race any misbehavior or award penalties. Athletes must not leave anything they take with them along the route, including gels, food or anything else. Abandonment of rubbish may lead to disqualification.





For anything not provided for in these regulations, please refer to the regulations of the Italian OCR Championship issued by the Italian OCR Federation and the Italian OCR Championship available on their respective websites.

PENALTIES

Faster athletes may ask for road and space to pass by shouting 'road' or 'permit' or similar. Competitive athletes who are joined by non-competitive athletes have no priority in the queue at obstacles. Athletes in the non-competitive buoys will have no penalty for failing to pass an obstacle.

Rules valid for competitive athletes on obstacles NOT IN SUSPENSION:

- immediately use the first attempt and second attempt lines if these are free
- in the case of a second attempt use only the second attempt lines
- in the case of multiple attempts use only the second attempt lines
- in the event of a failed attempt, if there is a queue, return to the back of the line and wait your turn
- it is forbidden to touch the structure supports
- the number of attempts is unlimited (except for suspended obstacles)
- in case of abandonment go to the judge and have your wristband cut off

GARMIN ONE (valid only for participants of the LONG competitive race)





Within each competitive race of the INFERNO SERIES circuit, a special kilometer may be identified, hence the name GARMIN ONE. The start and end of this section of the course will also be clearly identified by means of two chip control mats for recording the entry and exit times of each participant. The winners of the challenge, men and women, will be those who complete GARMIN ONE in the shortest possible time and overcome every obstacle, i.e. not losing any bracelets.

To give everyone a chance to win GARMIN ONE, each athlete will be given a special bracelet, valid ONLY for the GARMIN ONE kilometer.

The bracelet will bear the athlete's race number. The wristband will be cut off if an obstacle on the course is not passed.

The GARMIN ONE winner may not be the same as the overall winner. In this case the GARMIN ONE winner will be the athlete with the second best time.

NON COMPETITIVE RACE - OPEN (with sports medical certificate for NON-competitive activity)

Participants in the OPEN race are under no obligation to overcome obstacles, which they may attempt an unlimited number of times. They must assess the obstacle and their own ability to overcome it before proceeding to attempt it. Participants in the OPEN category are equipped with timing chips, the ranking will be drawn up on the basis of the finish time but will not be valid for FIOCR rankings, qualifications and rankings. In the OPEN category the current sanitary regulations, i.e. for illustrative purposes the spacing, must be applied in any case.

No prize-giving is provided for the OPEN category.





Organization personnel will monitor the course and obstacles to ensure that the race proceeds smoothly and in accordance with the rules. In the event of non-compliant behavior, the staff may report the bib number to the organization and the competitor may be disqualified even if he or she finishes the race. The course and obstacles are designed in such a way as to limit the waiting time in front of each obstacle as much as possible. However, in the event of a wait, the Organisation expects each participant to behave in a fair and polite manner. Please remember that INFERNO is a potentially dangerous obstacle course and the safety of participants is the Organisation's top priority.

The Organisation reserves the right to change the course or close individual obstacles at any time. Every participant is expected to behave in a fair and sporting manner!

Disrespectful or offensive behavior towards staff, volunteers or judges may be punished by disqualification from the race and reporting for further sanction to the Italian OCR Federation.

INFERNO SERIES

Each participant in the PRO category of each INFERNO stage is automatically registered in the ranking of all INFERNO races of the year, which determines the **INFERNO SERIES** winners in the categories provided.

The ranking is given by the best three results, i.e. out of the four stages one result can be discarded. The minimum number of results is two. In the event of a tie, participation in the highest number of stages will be considered, in the event of a further tie, seniority will be given priority.

Participation in the last stage is compulsory for the final ranking and prize-giving, which takes place during the last INFERNO stage.

There is one ranking for SHORT races and one for LONG races.

There are prizes for the overall podium, for each age category podium and for the teams, the prizes are communicated in detail on the event webpage.

INFERNO PASS

For the period of time indicated on the INFERNO website you can purchase the PASS INFERNO SERIES, which entitles you to take part in all the INFERNO races of the year in the category of your choice, with an unmissable discount:

- PASS INFERNO SERIES LONG PRO includes entry to Inferno Snow Long PRO, to Inferno Park Long PRO, to Inferno Alp Long PRO, to Inferno Mud Long PRO
- PASS INFERNO SERIES LONG OPEN includes entry to Inferno Snow Long OPEN, Inferno Park Long OPEN, Inferno Alp Long OPEN, Inferno Mud Long OPEN
- PASS INFERNO SERIES SHORT PRO includes entry to Inferno Snow Short PRO, Inferno Park Short PRO, Inferno Alp Short PRO, Inferno Mud Short PRO
- PASS INFERNO SERIES SHORT OPEN includes entry to Inferno Snow Short OPEN, to Inferno Park Short OPEN, to Inferno Alp Short OPEN, to Inferno Mud Short OPEN

Entry to each individual race obtained with the PASS INFERNO SERIES is strictly personal and is NOT transferable to third parties, it CANNOT be transferred to another INFERNO race of the year (i.e. what is set out in art. 4 below for change of ownership and transfer is limited only to transfer to a possible race of the following year).

3. REQUIREMENTS FOR PARTICIPATION

Participation in the event is open to members of the organising society and the EPSs to which the organising society is itself affiliated. Participation will be permitted from the age of 12, for longer races there may be greater restrictions, regardless of nationality and gender.

Participation is open to those aged 16 years and over on race day, women men, of all nationalities. Participation will be permitted from the age of 13 for shorter distance races and the OPEN category.





MEDICAL CERTIFICATE

For participation in the OPEN category, a sports medical certificate for recreational (or non-competitive) sporting activity is required. For participation in the PRO (competitive) category, a sports medical certificate for competitive activity (type B1) is required, valid on the date of the race or issued no more than 12 months previously. For Italian athletes, it is compulsory to send a copy of the valid medical certificate for competitive activities according to the telematic modalities on the race website. The medical certificates accepted are those that correspond to model B1.

The medical certificate must be uploaded online by the day before the event on the registration platform. It will be possible to present it on the day of the race (also in paper format), in which case the organization reserves the right to charge up to 10 euros for administrative costs.

Participation will not be allowed for those who only present a sports federation card, RUNCARD or other sports promotion organization card, which is not accompanied by a medical certificate. Foreign athletes must have the certificate made available by the organization at www.infernorun.it completed, stamped and signed by a doctor.

The Organisation reserves the right not to accept a medical certificate that is illegible or unclear and consequently not to allow participation in the race. **THE MEDICAL CERTIFICATE MUST BE VALID ON THE DAY OF THE RACE (medical certificates expiring on the day of the race will not be accepted)**

DISCLAIMER

At the time of registration, on <u>www.infernorun.it</u>, those wishing to participate in the INFERNO sign the knowledge and acceptance of these regulations and the relevant releases on the processing of images, GDPR and privacy information also available as an attachment to these regulations.

Additional disclaimers and/or health certifications may be requested where the regulations in force on the date of the event so require.

4. TERMS OF REGISTRATION

First-time registrants enjoy preferential treatment over last-time registrants. The minimum registration fees are listed on infernorun.co.uk.

The registration fee includes:

- Timing service with microchip
- official jersey (size subject to availability) INFERNO;
- bag storage service (if health regulations permit)
- shower service (if health regulations permit)
- final refreshments (if and as health regulations permit)
- water points on the route (if and as health regulations permit)
- race package
- sports insurance cover

The registration procedure can be found on the official website <u>www.infernorun.it</u>. In order to proceed with registration, the following are required: personal data, acceptance of privacy, acknowledgement and acceptance of the regulations, the health waiver where present, a copy of the medical certificate (which can also be uploaded later, before the date of the race) and payment of the registration fee in the prescribed manner.

Entries can only be made online at www.infernorun.it and the accepted methods of payment are indicated on the same site.





The organization reserves the right to close or re-open registrations at any time it deems appropriate and in any case by giving notice on www.infernorun.it.

Registration will not be canceled or refunded for any reason that prevents participation by the subscriber.

In the event of cancellation of the event due to a public order emergency or natural disaster, members will be granted a voucher to register for an event within the next 12 months or, at their choice, a 100% refund of the amount paid net of payment processing fees on the platform used.

CHANGE OF CATEGORY

i.e. change from OPEN to PRO category is regulated as follows - by sending your request by email to iscrizioni@infernorun.it -:

- 20 euro per change from OPEN to PRO (if places are available)
- no cost for change from PRO to OPEN

CHANGE OF OWNERSHIP

(change of participant's name) is regulated as follows - by sending your request by email to iscrizioni@infernorun.it-:

- no cost for change of ownership up to 48 hours before the event
- no change possible within 48 hours before the event

For TRANSFER TO ANOTHER INFERNO RACE

keeping the same ownership - by sending your request by email to iscrizioni@infernorun.it -:

- 10 euros for transfer to another INFERNO competition up to 48 hours before the event
- no transfer possible in the 48 hours before the event

The organization for each of the changes described above will produce a digital voucher for use on the registration platform of the value necessary to complete the registration process for the agreed change within 30 days of the production of the aforementioned voucher. After 30 days the value of the voucher will not be changed, not even as the cost of the registration fee for the chosen race increases.

5. ENVIRONMENTAL SUSTAINABILITY

The organization and its partners respect environmental sustainability in all aspects of their activities. Therefore, all participants and persons involved in the event are obliged to protect the environment. Compliance with legal regulations relating to the environment is an essential condition for taking part in the event. This concerns above all waste management, soil conservation, water conservation and pollution control. Specific waste collection containers will be set up and all participants are invited to actively participate in waste collection. A shoe collection service will also be set up.

6. BIB AND SWAG COLLECTION

Race bibs and the swag can be collected at the INFERNO Village on the day of the race or in other ways that will be communicated. Bibs may also be collected by third parties, with a written proxy and a photocopy of a valid identity document of the delegating person. Collection by third parties may be prevented by health regulations. The race bib is strictly personal, cannot be tampered with and is not transferable to anyone.

7. TIMING AND TIME LIMIT





Participants in the race will be equipped with one or more chips to record their race time, and a finish order will be drawn up on the basis of the time recorded. The timekeeping and processing of the finish orders will be carried out electronically and failure to return the transponder chip may result in a charge of up to €10 for the participant.

The time limit is set for each race and communicated at the start. Beyond this time, the organization will not guarantee the complete safety of the race course and timing will not be continued. Any participant who fails to meet this limitation will be recorded as 'NOT COMPLETED' in the results list. In any case, the race may be completed by all participants crossing the finish area.

8. BAG DEPOT, CHANGING ROOMS AND SHOWERS

Changing rooms and bag depots, if such services are available and permitted by governmental and sanitary regulations in force on the date of the race, are available to participants near the finish/start area. The shower service, if available, may be subject to waiting times depending on the number of participants. In this case, we recommend appropriate and civilized behavior while waiting.

The organization accepts no responsibility for personal items unattended or forgotten in these areas or for theft or damage.

9. STARTING PROCEDURE

Athletes taking part in the competitive race will start first, in one or more groups (bolge) depending on their overall number and the health regulations in force. The number of PRO and OPEN HELL groups (bolge) will be decided by the organization on the basis of the number of participants, obstacles, safety and health regulations in force.

The Organisation reserves the right to change the procedure and starting times to improve the smooth running of the race. In such cases, changes will be communicated in good time.

10. ATHLETE RESPONSIBILITY

The athlete is obliged to be informed about the regulations, how to overcome the obstacles and the details of the event communicated on the official event website.

The registered athlete is responsible for the ownership and safekeeping of his race bib and acquires the right to use all services mentioned in these regulations and/or subsequently communicated.

- a) Anyone who, without regular registration, takes part without a bib number, as well as being held liable for damage to persons or property, including himself, will incur sporting sanctions under the jurisdiction of the federal bodies and may be liable to the criminal sanctions provided for the offense of "theft" (art. 624. penal code).
- b) Anyone who, without regular registration, takes part with a forged or otherwise non-compliant bib number, as well as being liable as indicated above, will incur sporting penalties and may also be liable to the criminal sanctions provided for the offense of "theft" (art. 624. criminal code), or, alternatively, for the offense of fraud (art. 640. criminal code). In cases a) and b), participants may be liable to the penalties laid down for the offense of "failure to comply with the provisions of the Authorities" (Article 650 of the Criminal Code). The aforementioned cases will only be found after verification of photographic and/or video documentation.





11. AWARDS

Prizes in kind will be awarded to the first three men, the first three women and the first three teams in the competitive race. If logistics and timing permit, prizes will also be awarded to the first in each age category. The prize-giving ceremony will take place approximately two hours after the end of the competitive race at the finish area. The final results and the alphabetical order of finish will be published after the end of the race on the official website and/or the timing service website.

Prizes, if available, will only and only be given to those present at the ceremony, they will not be handed out afterwards or sent out.

The prize-giving will in any case be carried out in accordance with current health regulations.

12. MEDICAL SERVICE AND ASSISTANCE

The organization will provide an appropriate medical service on the route and at the start and finish points. Ambulances, first-aid facilities and paramedical services, located at key points along the route, will provide the appropriate medical service to all participants. The doctors and paramedical personnel are authorized to prohibit injured, overworked or injured participants from continuing the race in order to ensure the medical safety of all participants.

13. OBSTACLES WARNINGS

Walls and wooden palisades are to be overcome by passing over the wall using whatever technique the participant feels able to perform in safety of himself and others.

Each wall may have imperfections and cause small wounds caused by splinters of wood. The obstacle must also be tackled with due attention to the landing part on the opposite side.

Each participant must assess his or her own physical condition and the condition of the ground on which the obstacle rests and on which he or she is to land. In the event of rain or other weather, the contact surfaces may be slippery and offer less grip and support. Ropes may be present to assist in overcoming the obstacle; such ropes should only be used for their intended purpose. For example, ropes for ascending should not be used for descending.

It is the responsibility of each participant to check that each rope is held correctly before use.

Exiting or disengaging from the obstacle must be performed according to the rules of each obstacle. Each obstacle may vary the method of exit, which must always be performed in the safest way for the participant.

In the case of balance hurdles the support surface is reduced and can be slippery and lead to the athlete falling. In the case of rain or other weather events the surfaces can be even more slippery.

In weight-carrying obstacles, each participant must assess his or her own endurance and technique appropriate to the effort in order not to cause the carried object to fall either on himself or on the other participants. Carried objects must be supported but not dropped or thrown when completing the obstacle.

In water obstacles where swimming is required, it is compulsory to know how to swim, otherwise it is forbidden to engage such obstacles; to do so without knowing how to swim puts one's own and others' safety at risk and is liable to penalties.

In mud pools it is forbidden to dive head-on and it is compulsory for each participant to assess before entering that the entry area is free and clear of other participants so as not to run the risk of being even partially submerged or of submerging others.

In suspended obstacles, each participant must assess his or her grip capacity (grip on the obstacles). It is possible to skip a grip and go directly to the next one by assessing one's athletic ability but with the knowledge that there is a greater likelihood of losing the grip and thus falling.





Each participant must therefore avoid finding themselves even momentarily in positions or situations that prevent a safe landing for themselves or others.

On all obstacles, the position of the feet must remain lower than that of the head.

Finally, each participant must bear in mind that during the course it may happen to be partially or completely wet and that therefore, by way of example, wet hands may have less or different grip on all types of obstacles, entailing a greater risk of accidents and/or falls

14. FURTHER WARNINGS

The event shall be held in all weather conditions, without prejudice to the right of the organizers to suspend the race for reasons of participant safety or public order.

The Organisation reserves the right to cancel the event, postpone it, anticipate it or postpone it, and to amend these regulations at any time for reasons it deems appropriate for the better management of the race or for the health of the participants, at its sole discretion.

Any changes to services, venues and times will be duly communicated to entrants by email and will be posted on www.infernorun.it.

Addendum Inferno race to Team of 3 participants

INFERNO TEAM (MUD EDITION ONLY)

INFERNO organizes an OCR race for freely composed teams on a course to be defined with approximately 15 obstacles to be overcome together. It is not a relay race.

These regulations are to be considered an integral part of the general regulations (INFERNO regulation 2023) which, with the participants' guide, form a single body of law.

1. RACE, RULES AND DISQUALIFICATIONS

INFERNO TEAM will have team starts, i.e. team members will start together. The time will be recorded with an electronic chip and the time recorded by the last team member will count. We suggest that each team wears the same jersey or colors or a distinctive team sign to facilitate the judges and volunteers in carrying out their tasks.

TEAM CATEGORIES

- team WWW
- team MMM
- team MIX (2 WW and 1 M or 2 MM e 1 W)

GENERAL RULES APPLY:

The start and finish of the components must be within 60" of each other, i.e. no more than one minute may elapse between the first and last recorded time. The team starts, runs and finishes together.

Each obstacle must be passed together following the same line, i.e. in each obstacle each team may occupy a maximum of one lane. Without changing the lane chosen by the first athlete, therefore, the second athlete of the team will proceed to overcome the obstacle as soon as the first has touched the bell placed at the end of the lane and the same will happen for the third athlete of the team.





There will be obstacles on the course that must be overcome by each team in co-operative mode. By way of illustrative but not exhaustive example, there will be transports that must be performed by the entire team simultaneously, balances or other tests that will engage the entire team.

In the case of a competitive race, each team member will have 3 wristbands. In order for the team to enter the ranking, each athlete of each PRO team must have at least one wristband still on their wrist at the time of the Penalty Loop. Each suspended obstacle will only have 1 attempt. Each failure or failure of an obstacle will result in 1 wristband being cut off the wrist of the athlete who has failed it.

Lost wristbands may be recovered through the Penalty Loop system. The Penalty Loop will be performed by teams.

Participants in the **TEAM OPEN** competition will have no obligation to pass the obstacle and will not have the three wristbands.

2. STARTING PROCEDURE

In order not to create crowds, starting times for each team will be drawn up and communicated. The starting times will be published on the event website and may also change on the day itself. Unless otherwise indicated, we recommend that you arrive at least 90 minutes before the scheduled starting time.

3. REQUIREMENTS FOR PARTICIPATION

The event is open to everyone who is 13 years of age or older on the day of the race, women, men, of all nationalities. For minors, the authorisation of a parent or guardian is required. You may only participate once in each race; you register for the race, not the battery.

FUNDAMENTAL REQUIREMENT is the presentation of a valid sports medical certificate for non-competitive activity and a release for minors.

4. TERMS OF CHANGE OR TRANSFER OF REGISTRATION

Each team may change its participants up to seven (7) days before the competition. Each change has a cost of 10 euros. It will not be possible to change team participants during the seven (7) days prior to the race. Should any one or two of the team members be unable to participate on the day of the race, the other team members who turn up on the day of the race may participate in Inferno OPEN as individuals at no extra cost.

INFERNO reserves the right to amend all or part of this document. Always check the updated document.

INFORMATION ON DATA PROCESSING (GDPR and PRIVACY) ANDROMEDA SPORT SSD ARL GDPR privacy policy

By requesting to participate in the INFERNO race, I declare that I am aware of the characteristics of the race, that I am NOT under the influence of medication, alcohol or drugs; that I am physically prepared and that I am aware that only a careful personal assessment of my own condition is a guarantee of safety for me and for others.
