RACE REGULATION INFERNO 2026

The following conventions apply throughout the document:

- The Italian terms bolgia / bolge are intentionally maintained in their original form and are not translated (used to indicate start waves/heats).
- The Italian term pettorale is translated as BIB number.
- Technical OCR terminology is used consistently (e.g. Penalty Loop, suspended obstacles, attempts, carries, grip, lanes, heats, DNF/DNC).
- The structure, numbering, wording, and legal-regulatory meaning strictly mirror the original Italian regulation.

The race named **INFERNO** is an obstacle course running (OCR) event. The event consists of one or more running races with distances ranging from 2 km to 14 km, featuring natural and artificial obstacles, on mixed terrain including asphalt, dirt, and/or snow. The event is open to all participants, men and women, aged 16 and over (from 12 years of age for shorter distances), holding a valid medical certificate (see specifications below).

Before each event, the official course map and the Athlete Guide are published and must be considered an integral part of this Regulation.

Any additional limitations or restrictions deriving from regulations, governmental decrees (DPCM), or other legal provisions compared to what is stated below will be communicated on the official event website and related social media channels.

1. COURSE AND OBSTACLES

The total length of the course may vary for each event and will be communicated on the official event website. The course will include both natural and artificial obstacles. The official course map will be published on www.infernorun.it.

In addition to dexterity, climbing ability, jumping, and swimming skills, running speed will also be essential to successfully complete the competition. The course may include crossings of ditches, forests, uneven terrain with wood, logs or roots, wires or ropes, rubble or surface rocks, icy or snowy sections, crossings of rivers, streams, lakes, and natural or artificial water pits. The risk of tripping and falling is constant.

The Organization emphasizes that injuries and/or accidents may occur during obstacle negotiation as well as along the entire race course. Hazards may also be caused by falls or actions of other participants. Therefore, participants are strongly advised to adjust their pace according to terrain conditions, visibility, the type of obstacle being approached, and congestion along the course. Each obstacle has its own mandatory execution and engagement rules that must be followed for the safety of all involved.

Due to the number of participants, full visibility of the race terrain cannot always be guaranteed. In such cases, participants are prohibited from continuing at maximum speed and are required to reduce speed in order to adapt to terrain configuration and visibility conditions. When approaching each obstacle, participants must pay maximum attention to the information signage and to the instructions provided by the obstacle staff. More detailed information regarding the course and its obstacles will be available on the official website and in the Athlete Guide.





2. RACE, RULES AND DISQUALIFICATIONS

Obstacles are placed along the course to challenge participants. The race is open to both competitive and non-competitive participation.

COMPETITIVE RACE – PRO (with competitive sports medical certificate)

Competitive participants will start first, in one or more reserved **bolge**, and will be assigned a BIB number displayed on each wristband. They will be equipped with one or more timing chips for race time detection. The Race Direction reserves the right to divide or move participants (e.g. men and women or bolge composition) if deemed necessary for organizational or health reasons.

The Race Direction reserves the right to modify start times and the selected bolgia during registration if functional to the execution of the race.

Athletes serving a doping suspension or suspended by the Italian OCR Federation (FIOCR) are prohibited from participating in the competitive race.

For competitive participants, obstacles must be correctly completed and not bypassed, without receiving external assistance. Otherwise, the obstacle will be considered failed.

Each competitive athlete is provided with five wristbands (STANDARD RACE) or three wristbands (SHORT RACE), also referred to as bands, depending on race distance. All wristbands must be worn and are required for access to the start pen. Wristbands are personal, display the BIB number, and may not be transferred.

Each athlete wears 5 or 3 wristbands depending on the race (Standard or Short). On suspended obstacles only one attempt is allowed. Failure of an obstacle results in the cutting of one wristband.

In accordance with the FIOCR Competitive Regulation, certain obstacles will apply an on-site Penalty Loop. In this case, the correct execution of the penalty will be monitored and will not result in wristband cutting.

Therefore, in case of failure on a single-attempt obstacle, the penalty may be served on site. Penalty Loop guidelines remain unchanged. Each race will include at least two obstacles that require wristband cutting or do not provide on-site penalties. Consequently, the final Penalty Loop before the finish line remains mandatory. Obstacles with on-site penalties will be specified in the race documents.

Before the finish line, athletes are filtered based on the number of wristbands in their possession:

- with 5 wristbands (Standard) or 3 wristbands (Short), athletes may proceed directly to the finish line for time recording;
- with 0 wristbands, athletes may proceed directly to the finish line; they will appear in the results as DNF (Did Not Finish) with recorded time;
- with at least 1 wristband, athletes must complete the Penalty Loop (from 1 to 4 times depending on the race) to recover missing wristbands. Upon successful completion, they may proceed to the finish line for time recording.

PENALTY LOOP

- Consists of a running, carry, strength-based or other task;
- Must be completed a number of times equal to the lost wristbands, up to a maximum of 4 times for Standard races and 2 times for Short races;
- Is positioned near the finish line or directly at the obstacle where applicable;
- Failure to complete the Penalty Loop results in removal of all wristbands and classification as DNF or DNC;
- An electronic control mat may be installed to verify passage through the Penalty Loop





For each failed obstacle, a band is cut and retained by the judge as evidence for a possible final check. Since athletes cross the finish line with zero bracelets (DNF, did not finish) or three for the Short or five for the Standard, the final ranking is based on the finishing time and includes only those with three bracelets for the Short or five for the Standard.

Once the course is completed, and in any case before the start of the race, the race director will announce the time limit beyond which participants will not be counted in the rankings.

The race director may use a "Broom" service (an athlete from the organization who starts last) to "clean" the course and close the competitive race. This system may be replaced or supplemented by time gates that indicate a time limit within which to reach a specific point on the course or the finish line.

Competitive athletes are strictly forbidden, under penalty of disqualification, from testing obstacles before the race. It is the duty and responsibility of each competitive participant to ensure that, upon arrival, the race judge correctly records the number of wristbands with which the race is completed. Each athlete is responsible for their own control devices (wristbands and timing chip); the absence of one or more of these devices may not be contested under any circumstances. Immediately after the finish line, each athlete must have the number of wristbands with which they completed the race recorded.

The course may not be cut. Athletes who gain advantage by shortening the course or avoiding obstacles will be disqualified. An electronic split-timing mat may be used to provide real-time detection and verify actual passage. Judges in plain clothes may also be present among athletes to report improper behavior or assign penalties either at obstacles or after the race.

Athletes must not abandon any items along the course, including gels, food, or other materials. Littering may result in disqualification.

In accordance with FIOCR guidelines and the Youth, Short & Standard Selection Committees, in SHORT and STANDARD races U16 athletes will not face strength-based obstacles such as carries, drags, or flips. They will therefore have separate rankings and qualifications.

For matters not expressly provided for in this Regulation, reference is made to the Italian OCR Championship Regulations issued by the Italian OCR Federation and the Italian OCR Championship, available on their respective websites.

PENALTIES

Faster athletes may request space to pass by calling out "strada", "permesso", or similar expressions. Competitive athletes caught by non-competitive athletes have no priority at obstacle queues. Athletes starting in non-competitive bolge will incur no penalties in case of failure to complete an obstacle.

Rules applicable to competitive athletes on NON-SUSPENDED obstacles:

- immediately use the first-attempt lane and the second-attempt lane if available;
- in case of a second attempt, use only the designated second-attempt lanes;
- in case of multiple attempts, always use only the second-attempt lanes;
- in case of failed attempt, if a queue is present, return to the back of the line and wait for one's turn;
- touching structural supports is prohibited;
- the number of attempts is unlimited (except for suspended obstacles);
- in case of abandonment, report to the judge to have the wristband cut.





NON-COMPETITIVE RACE – OPEN (with non-competitive sports medical certificate)

Participants in the OPEN race are not required to complete obstacles and may attempt them an unlimited number of times. They must independently assess the obstacle and their own ability before attempting it. OPEN participants are equipped with timing chips; rankings will be based on finish time but will not be valid for FIOCR rankings, qualifications, or official standings.

In the OPEN category, applicable health regulations must in any case be respected, including distancing where required.

No awards are provided for the OPEN category.

Organization staff will monitor the course and obstacles to ensure the race proceeds smoothly and in compliance with the rules. In case of non-compliant behavior, staff may report the BIB number to the Organization and the participant, although finishing the race, may be disqualified.

The course and obstacles are designed to minimize waiting time at each obstacle. In any case of waiting, participants are expected to behave fairly and respectfully. INFERNO is a potentially dangerous obstacle race and participant safety is the Organization's highest priority.

The Organization reserves the right to modify the course or close individual obstacles at any time. Each participant is required to behave fairly and sportingly. Disrespectful or offensive behavior toward staff, volunteers, or judges may result in disqualification and reporting to the Italian OCR Federation for further sanctions.

3. PARTICIPATION REQUIREMENTS

Participation is open to members affiliated with the organizing club and the Sports Promotion Bodies (EPS) to which the organizer is affiliated (including those who request membership during registration). Participation is permitted from the age of 12; longer-distance races may have additional restrictions, regardless of nationality or gender.

MEDICAL CERTIFICATE

For participation in the OPEN category, a sports medical certificate for recreational motor activity (or non-competitive sports activity) is required. For participation in the PRO (competitive) category, a competitive sports medical certificate (type B1) is required, valid on the race date and issued no more than 12 months prior.

Italian athletes must upload a valid competitive medical certificate according to the online procedures indicated on the race website. Accepted certificates must comply with the B1 model.

The medical certificate must be uploaded online no later than the day before the event via the registration platform. It may also be presented on race day (including paper format); in this case, the Organization reserves the right to request up to €20 to cover administrative management costs.





Participation will not be permitted to those presenting only a federation card, RUNCARD, or card from another sports promotion body without an accompanying medical certificate. Foreign athletes must have the certificate provided by the Organization on www.infernorun.it completed, stamped, and signed by a physician.

The Organization reserves the right not to accept illegible or unclear medical certificates and consequently to deny participation. THE MEDICAL CERTIFICATE MUST BE VALID ON THE DAY OF THE RACE.

LIABILITY WAIVER

By registering on www.infernorun.it, participants declare knowledge and acceptance of this Regulation and the related waivers concerning image rights, GDPR, and privacy, also attached to this Regulation. Additional waivers and/or medical certifications may be required if mandated by regulations in force at the time of the event.

4. REGISTRATION PROCEDURES

Early registrations benefit from preferential conditions compared to late registrations. Minimum registration fees are published on the official website www.infernorun.it.

The registration fee includes:

- timing service with microchip and wristbands;
- official INFERNO gadget (size subject to availability);
- bag deposit service (if available and permitted by health regulations);
- shower service (if available and permitted by health regulations);
- post-race refreshment (if and as permitted by health regulations);
- water stations along the course (if and as permitted by health regulations);
- race pack;
- sports insurance coverage.

Registration procedures are indicated on the official website. To complete registration, the following are required: personal data, acceptance of privacy policy, acknowledgment and acceptance of this Regulation, acceptance of the medical waiver if applicable, upload of the medical certificate (which may also be uploaded later, by race date), and payment of the registration fee using the accepted methods.

Registrations are accepted exclusively online via www.infernorun.it using the payment methods indicated. The Organization reserves the right to close or reopen registrations at any time, with notice published on the official website.

Registration will not be cancelled or refunded for any reason preventing the registered participant from attending.

In case of cancellation of the event due to public emergency or natural disaster, registered participants will be granted either a voucher valid for registration to an event within the following 12 months or, alternatively, a refund of 100% of the amount paid, net of payment platform management fees.

CATEGORY CHANGE, i.e., moving from the OPEN to the PRO category, is handled as follows - by sending your request via email to iscrizioni@infernorun.it -:

You will be notified of the delta to be paid, i.e., the difference between the fees for the two categories (if places are available).





There is no fee for moving from PRO to OPEN.

For **TRANSFERRING TO ANOTHER INFERNO RACE** while maintaining the same ownership - by sending your request via email to iscrizioni@infernorun.it -:

€10 for transferring to another INFERNO race up to 7 days before the event.

No changes are possible within 7 days before the event

For each of the changes described above, the organization will issue a digital voucher - valid for 30 days - to be used on the registration platform to complete the registration process for the agreed-upon change. During the 30-day validity period of the voucher, the value of the voucher will not change, not even if the registration fee for the chosen race increases.

This procedure may be replaced by an automated procedure on the registration platform, as in the case of CHANGE OF OWNERSHIP:

CHANGE OF OWNERSHIP (name change) is possible directly from the registration platform by accessing your private registration area and is regulated as follows:

€10 for change of ownership up to 7 days before the event

No changes are possible within 7 days before the event

"Day before the event" means a request received through the channels listed above by 11:59 PM on the eighth day before the event in question. For example, if the race is on Saturday, May 9th, the request must be received by 11:59 PM on Friday, May 1st.

5. RULES & SERVICES

1. ENVIRONMENTAL SUSTAINABILITY

The organisation and its partners respect environmental sustainability in all aspects of their activities. Therefore, all participants and persons involved in the event are obliged to protect the environment. Compliance with legal regulations relating to the environment is an essential condition for taking part in the event. This concerns above all waste management, soil conservation, water conservation and pollution control. Specific waste collection containers will be set up and all participants are invited to actively participate in waste collection. A shoe collection service will also be set up.

2. BIB AND SWAG COLLECTION

Race bibs and the race pack can be collected at the INFERNO Village on the day of the race or in other ways that will be communicated. Bibs may also be collected by third parties, with a written proxy and a photocopy of a valid identity document of the delegating person. Collection by third parties may be prevented by health regulations. The race bib is strictly personal, cannot be tampered with and is not transferable to anyone.

3. TIMING & TIME LIMIT

Participants in the race will be equipped with one or more chips to record their race time, and a finish order will be drawn up on the basis of the time recorded. The measurement of times and the processing of finish orders will be carried out electronically and failure to return the transponder chip may result in a charge of up to €10 for the participant.





The time limit is set for each race and communicated in the "athletes' guide" and at the start. Beyond this time, the organisation will not guarantee assistance on the course and the safety of the race route and timing will not be continued. Any participant who fails to comply with this limitation will be recorded as "NOT COMPLETED" in the results list. In any case, the race can be completed by all participants crossing the finish area.

4. BAG DROP, SHOWERS

Changing rooms and bag storage, if such facilities are available and permitted by governmental and sanitary regulations in force on the date of the race, are available to participants near the finish/start area. The shower service, if available, may be subject to waiting times depending on the number of participants. In this case, we recommend appropriate and civilised behaviour while waiting.

The organisation accepts no responsibility for personal items unattended or forgotten in these areas or for theft or damage.

5. STARTING PROCEDURE

Athletes taking part in the competitive race will start first, in one or more groups (bolge) depending on their overall number and the health regulations in force. The number of PRO and OPEN HELL groups (bolge) will be decided by the organisation on the basis of the number of participants, obstacles, safety and health regulations in force.

The Organisation reserves the right to change the procedure and starting times to improve the smooth running of the race. In such cases, changes will be communicated in good time.

6. ATHLETE RESPONSIBILITY

The athlete is obliged to be informed about the regulations, how to overcome the obstacles and the details of the event communicated on the official event website.

The registered athlete is responsible for the ownership and safekeeping of his race bib and acquires the right to use all the services mentioned in these regulations and/or subsequently communicated.

- a) Anyone who, without regular registration, takes part without a race bib, in addition to being held liable for damage to persons or property, including himself, will incur sporting sanctions under the jurisdiction of the federal bodies and may be liable to the criminal sanctions provided for the offence of "theft" (art. 624. penal code).
- b) Anyone who, without regular registration, takes part with a forged or otherwise non-compliant bib number, as well as being liable as indicated above, will incur sporting penalties and may also be liable to the criminal sanctions provided for the offence of "theft" (art. 624. criminal code), or, alternatively, for the offence of fraud (art. 640. criminal code). In cases a) and b), participants may be liable to the penalties laid down for the offence of "failure to comply with the provisions of the Authorities" (Article 650 of the Criminal Code). The aforementioned cases will only be found after verification of photographic and/or video documentation.

7. AWARDS

Prizes in kind will be awarded to the first three men, the first three women and the first three teams in the competitive race. If logistics and timing permit, prizes will also be awarded to the first in each age category.

The prize-giving ceremony will take place approximately two hours after the end of the competitive race at the finish area. The final results and the alphabetical order of finish will be published if possible in real time and in any case after the end of the race on the official website and/or the timing service website.

Prizes, if available, will only and only be given to those who are present at the ceremony, they will not be delivered later or even sent out.





The prize-giving will in any case be carried out in accordance with current health regulations.

8. MEDICAL HELP & ASSISTANCE

The organisation will provide an appropriate medical service on the route and at the start and finish points. Ambulances, first-aid facilities and paramedical services, located at key points along the route, will provide the appropriate medical service to all participants. The doctors and paramedical personnel are authorised to prohibit injured, overworked or injured participants from continuing the race in order to ensure the medical safety of all participants.

9. OBSTACLES WARNINGS!

Walls and wooden palisades are to be overcome by passing over the wall using whatever technique the participant feels able to perform safely for himself and others.

Each wall may have imperfections and cause small wounds caused by splinters of wood. The obstacle must also be tackled with due attention to the landing part on the opposite side.

Each participant must assess his or her own physical condition and the condition of the ground on which the obstacle rests and on which he or she is to land. In the event of rain or other weather, the contact surfaces may be slippery and offer less grip and support. Ropes may be present to assist in overcoming the obstacle; such ropes should only be used for their intended purpose. For example, ropes for ascending should not be used for descending.

It is the responsibility of each participant to check that each rope is secure before use.

Exiting or disengaging from the obstacle must be performed according to the rules of each obstacle. Each obstacle may vary the method of exit, which must always be performed in the safest way for the participant.

In the case of balance hurdles the support surface is reduced and can be slippery and lead to the athlete falling. In the case of rain or other weather events the surfaces can be even more slippery.

In weight-carrying obstacles, each participant must assess his or her own endurance and technique appropriate to the effort in order not to drop the carried object either himself or herself or on the other participants. Carried objects must be supported but not dropped or thrown when completing the obstacle.

In water obstacles where swimming is required, it is obligatory to know how to swim, otherwise it is forbidden to engage such obstacles; to do so without knowing how to swim puts one's own and others' safety at risk and is liable to penalties.

In mud pools it is forbidden to dive head-on and it is compulsory for each participant to assess before entering that the entry area is free and clear of other participants so as not to run the risk of being even partially submerged or of submerging others.

In suspended obstacles, each participant must assess his or her grip capacity (grip on the obstacles). It is possible to skip a grip and go directly to the next one by assessing one's athletic ability but with the knowledge that there is a greater likelihood of losing the grip and thus falling.

Each participant must therefore avoid finding themselves even momentarily in positions or situations that prevent a safe landing for themselves or others.

On all obstacles the position of the feet must remain lower than that of the head

Finally, each participant must bear in mind that during the course they may find themselves partially or completely wet and that therefore, by way of example, wet hands may have less or a different grip on all types of obstacles, entailing a greater risk of accidents and/or falls





10. LAST ADVICES...

The event shall be held in all weather conditions, without prejudice to the right of the organisers to suspend the race for reasons of participant safety or public order.

The Organisation reserves the right to cancel the event, postpone it, anticipate it or postpone it, and to amend these regulations at any time for reasons it deems appropriate for the better management of the race or for the health of the participants, at its sole discretion.

Any changes to services, venues and times will be duly communicated to entrants by email and will be posted on www.infernorun.it.





Addendum Inferno Team of 3 participants

INFERNO TEAM

INFERNO organises an OCR competition for freely composed teams on a course to be defined with about 15 obstacles to be overcome together. It is not a relay race.

These regulations are to be considered an integral part of the general regulations (INFERNO 2024 regulations) which, with the participants' guide, form a single body of law.

RACE, RULES AND PENALTIES

- INFERNO TEAM will have team starts, i.e. team members will start together. The time will be recorded with an electronic chip and the time recorded by the last team member will count. We suggest each team to wear the same jersey or colours or a distinctive sign of the team to facilitate the judges and volunteers in carrying out their tasks.

TEAM CATEGORIES

- team of 3 women
- team of 3 men
- mixed team (2 women and 1 man or 2 men and 1 woman)

GENERAL RULES:

Start and finish of the components must be within 60" of each other, i.e. no more than one minute may elapse between the first and last time recorded. The team starts, runs and finishes together.

Each obstacle must be passed together following the same line, i.e. in each obstacle each team may occupy a maximum of one lane. Without changing the lane chosen by the first athlete, therefore, the second athlete of the team will proceed to overcome the obstacle as soon as the first has touched the bell placed at the end of the lane and the same will happen for the third athlete of the team.

There will be obstacles on the course that must be overcome by each team in co-operative mode. By way of illustrative but not exhaustive example, there will be transports that must be performed by the entire team simultaneously, balances or other tests that will engage the entire team.

In the case of a competitive race, each team member will have 3 wristbands. In order for the team to enter the ranking, each athlete of each PRO team must have at least one wristband still on their wrist at the time of the Penalty Loop. Each suspended obstacle will only have 1 attempt. Each failure or failure of an obstacle will result in 1 wristband being cut off the wrist of the athlete who has failed it.

Lost wristbands may be recovered through the Penalty Loop system. The Penalty Loop will be performed by teams.

Participants in the TEAM OPEN competition will have no obligation to pass the obstacle and will not have the three wristbands.





STARTING ARRANGEMENTS

In order not to create crowds, starting times will be drawn up and communicated for each team. The starting times will be published on the event website and may also change on the day itself. Unless otherwise indicated, we recommend that you arrive at least 90 minutes before the scheduled start time.

PARTICIPATION REQUIREMENTS

The event is open to all persons aged 13 and over on the day of the race, women, men, of all nationalities. For minors, the authorisation of a parent or guardian is required. You may only participate once in each race; you register for the race, not the battery.

FUNDAMENTAL REQUIREMENT is the presentation of a valid sports medical certificate for competitive activity and a release for minors.

MODALITIES FOR CHANGING OR TRANSFERRING ENTRIES

Each team may change its participants up to seven (7) days before the race. Each change has a cost of 10 euros. It will not be possible to change team participants during the seven (7) days prior to the race. Should any one or two of the team members be unable to participate on the day of the race, the other team members who turn up on the day of the race may participate in Inferno OPEN as individuals at no extra cost.

INFERNO reserves the right to amend all or part of this document. Always check the updated document.





Addendum Inferno DUAL of 2 participants

INFERNO DUAL

INFERNO is organizing an OCR race for pairs of freely chosen participants on a course that will be defined with approximately 15 obstacles. It is not a relay race.

This regulation should be considered an integral part of the general regulations in force, which, together with the participant guide, constitute a single set of rules.

RACE, RULES, AND PENALTIES

INFERNO DUAL will have paired starts: both members of the DUAL will start together.

The time will be recorded with an electronic chip, and the time of the last member of the pair will be the decisive factor.

Participants are advised to wear the same jersey, the same colors, or a distinctive sign to facilitate judges and volunteers in carrying out their duties.

DUAL CATEGORIES

DUAL of 2 women

DUAL of 2 men

Mixed DUAL (1 woman and 1 man)

GENERAL RULES

- The start and finish times must be within 60 seconds of each other, meaning no more than one minute can elapse between the first and last recorded times. The pair starts, runs, and finishes together.
- Each obstacle must be completed by one and only one DUAL member, freely chosen by the pair for each obstacle without prior communication. The other member must position themselves at the end of the obstacle and wait for their partner for the duration of the obstacle and may not intervene in any way.
- The athlete who is not tackling the obstacle:
 - may not touch any part of the obstacle;
 - may not stabilize holds or moving elements;
 - may not assist their partner in any way during the obstacle;
 - may not provide physical support that would give them an advantage.
 - may give directions and encourage their teammate.
- Each obstacle is therefore completed by a single athlete, except in the case of cooperative obstacles, which will be clearly indicated by the organizers. By way of example but not limited to, there may be transports to be carried out simultaneously, balance exercises or tests that require the coordinated action of both members of the DUAL.

COMPETITIVE SPECIFIC RULES (PRO)

In the case of a competitive race, each DUAL athlete will have three bracelets.





For the pair to be eligible for ranking, both athletes must have at least one bracelet on their wrist at the final Penalty Loop.

Each suspended obstacle will have only one attempt.

Failure to complete the obstacle will result in:

- The cutting of one bracelet from the athlete who completed it, if the obstacle requires direct cutting of the bracelet; or
- the execution of the Penalty Loop on the spot, if the obstacle requires an immediate penalty without cutting the bracelet.

PLEASE NOTE:

Both the on-site Penalty Loop and the final Penalty Loop, if applicable, must be completed by both DUAL participants, regardless of who failed the obstacle. Lost bracelets can be recovered according to the system established in the general rules via the final Penalty Loop.

OPEN REGULATIONS

Participants in the DUAL OPEN race are not required to complete the obstacle and will not be issued with the three bracelets.

They must, however, complete the race following the same procedures as those established for the PRO category, namely:

- Tackle obstacles using DUAL dynamics (a single athlete designated for each obstacle);
- Respect all positioning, non-assistance, and non-interference rules;
- Tackle any cooperative obstacles according to the organizers' instructions;
- Stay together, respecting time limits between members.

Since DUAL OPEN athletes do not have wristbands, they will not be subject to wristband cutting or the minimum requirements for entry into the PRO rankings, but they may still be subject to penalties according to the general regulations.

STARTING TIMES

To avoid crowds and queues, starting times for each DUAL event will be established and communicated. The times will be published on the event website and may be subject to change even on the day of the event. Unless otherwise indicated, we recommend arriving at least 90 minutes before the scheduled start time.

PARTICIPATION REQUIREMENTS

Anyone 12 years of age or older on the day of the race, men and women of all nationalities, may participate. Minors require parental or legal guardian authorization. Participants may only participate once per race: they register for the race, not for the heat.





Fundamental requirement:

- A valid sports medical certificate for competitive (PRO) and non-competitive (OPEN) sports activities and a parental release for minors are required.

REGISTRATION CHANGE OR TRANSFER PROCEDURES

Each DUAL participant may change their participant names up to seven (7) days before the race.

Each change costs €10.

It will not be possible to change DUAL participants in the last seven (7) days before the race.

If one of the two participants is unable to participate on race day, the other athlete may participate in the Inferno OPEN or PRO individual mode at no additional cost.
