ORGANISATION

PROMOTING ENTITY

Marbella Epic Trail (**MET**) is an ultra-exclusive experience developed and delivered by the **Ultra Trail Sierra Blanca Sports Club (CDUTSB)**, a renowned organisation specialising in high-level mountain events.

PREMIUM STRATEGIC PARTNERSHIP

This world-class event is supported institutionally and benefits from the strategic collaboration of leading public bodies and prestigious private partners, whose commitment to sporting excellence is reflected in their role as official sponsors and collaborators.

SPECIALISED TECHNICAL MANAGEMENT

The comprehensive management of the event — including operational coordination, advanced safety protocols, and environmental sustainability oversight — is handled by our specialised executive team, supported by certified technicians and a select group of highly qualified volunteers.

REGULATORY FRAMEWORK

These regulations form the comprehensive and mandatory legal framework for all participating athletes, effective from the moment of registration confirmation until the official conclusion of the event.

The organisation of MET reflects our unwavering commitment to operational excellence and the premium experience our athletes deserve.

THE EVENT

OFFICIAL DATE

MET will take place on **21 February 2026**.

STARTING POINT

The race will start on the [Marbella Promenade](#), in front of the Plaza del Mar shopping centre. Access to the assembly area will be via [Calle Rafael Zea, número 17C](#), with the start scheduled for 05:00.

TECHNICAL ROUTE

The route will traverse the municipal areas of Marbella, Ojén, Monda and Istán in the province of Málaga, passing through the Sierra Blanca massif. The course is demanding and technical, combining footpaths, forest tracks and rocky sections with varying levels of difficulty. The finish will be situated at the starting point on Marbella's seafront promenade.

OFFICIAL APPROVAL

The event is officially authorised by the Andalusian Federation of Mountain Sports, Climbing and Hiking (FADMES), ensuring compliance with the technical and safety standards required for a single-distance course.

NEW FINISH LOCATION - TECHNICAL INFORMATION

In order to optimise logistics and enhance the overall quality of the event experience, the finish line is being relocated to the same location as the start.

To ensure participant safety and maintain timing accuracy, a time neutralisation system will be implemented at the crossing point on Av. Bulevar Príncipe Alfonso de Hohenlohe.

The course will feature two consecutive checkpoints: Finish A (pre-crossing), situated before the finish chute, and Finish B (post-crossing), located immediately after the pedestrian crossing. The timing system will automatically deduct the time elapsed between both points, meaning that the interval between arriving at Finish A and completing the road crossing to Finish B will not count towards the participant's official time.

Results will display a specific split identified as "Boulevard Crossing (neutralised)", thereby guaranteeing complete fairness for all runners.

TECHNICAL CONSIDERATIONS

Participants should note that minor adjustments to the course may occur due to variations in GPS device accuracy during the event, while maintaining the integrity of the original route.

- ⌚ **CUT-OFF TIME SYSTEM** Cut-off times have been technically calculated to allow completion within the established schedule, taking into account strategic breaks for rest and nutrition.
- 📍 **CHECKPOINT PROTOCOL** Athletes are required to pass through all checkpoints and leave each section before the assigned cut-off time, regardless of their individual arrival time.
- 📍 **AUTOMATIC DESCALIFICATION** Any participant who fails to meet the established time limits will be automatically withdrawn from the competition for operational safety reasons.
- 📍 **OPERATIONAL CLOSURE** Checkpoints and aid stations will close following the passage of the official sweep team. This measure ensures overall safety and optimises the event's logistical management.

TECHNICAL NOTICE: Equipment sizes are final and cannot be modified, as they are high-end items produced under limited custom manufacturing run.

This self-management system is part of our premium a service philosophy, designed to offer total control and immediate response to our athletes.

MANDATORY TECHNICAL MATERIAL

TECHNICAL INSPECTION PROTOCOL

All mandatory material will be subject to **rigorous inspections** during bib collection and at strategic points along the course. Our certified technical officials will carry out thorough checks to ensure compliance with the safety standards set by the Federation.

STRICT COMPLIANCE: Failure to meet these technical specifications will result in immediate penalties or disqualification. Athletes who cannot demonstrate full adherence to the Organisation's protocols will be prohibited from continuing in the event.

DYNAMIC INSPECTION: All equipment, including items carried in backpacks, must be available for immediate inspection upon request from our technical officials or certified referees throughout the course.

MANDATORY TECHNICAL SPECIFICATIONS

ADVANCED BODY PROTECTION

- ✓ Technical trousers or compression tights – Minimum coverage below the knees
- ✓ Windproof jacket – With integrated hood, long sleeves, and fitted to the athlete's size
- ✓ Survival thermal blanket – Minimum size: 1.20m x 2.10m
- ✓ Technical protective gloves

PROFESSIONAL HYDRATION SYSTEM

- ✓ Primary hydration system – Minimum capacity of 1 litre + additional 500ml bottle
- ✓ **CRITICAL SECTION:** Full hydration is mandatory between Puerto de Marbella and Istán (*no aid stations in this area*)

NAVIGATION AND SAFETY EQUIPMENT

- ✓ Professional headlamp + spare batteries + red rear light (*mandatory activation at night*)
- ✓ Advanced GPS device or Sports watch with preloaded official track
- ✓ Fully charged mobile phone
- ✓ Emergency whistle
- ✓ Official race bib – must be visible at all times

- ✓ Technical cap, sports visor or protective bandana

ENVIRONMENTAL COMMITMENT



Sustainable Cup Required – As part of our commitment to environmental excellence, all plastic waste has been eliminated along the course. Each athlete must carry their own collapsible personal cup for exclusive use at aid stations. (Cups are also available for purchase at bib collection.)



This equipment protocol has been developed specifically to ensure survival and optimal performance in extreme conditions, maintaining the highest safety standards for all athletes.

MEDICAL PROTOCOL AND HEALTH ASSISTANCE

Medical Condition Declaration

During the registration process, each athlete must declare any food intolerances or medication allergies. This confidential information will be used exclusively to personalise available nutrition options and enhance the emergency response of our specialised medical team.

Personal Medication Responsibility

Each competitor is fully responsible for carrying and administering their prescribed medication throughout the event. This is an essential condition for safe participation.

Aid Station Assistance Protocol

Products such as Reflex (or an equivalent therapeutic product) will be available at aid stations for athlete use only. Volunteers are not authorised to apply these products.

Participants must self-administer such products after leaving the refreshment area and must return the product to the volunteers after use, ensuring the integrity of the health and safety protocol.

BIB ASSIGNMENT AND COLLECTION

- ✿ **DIGITAL IDENTIFICATION SYSTEM** To collect their race bib, athletes must present the official **QR code** received with their registration confirmation. This optimised system ensures maximum efficiency and minimises processing times.
- ✿ **ALTERNATIVE IDENTIFICATION** If the QR code is unavailable, athletes may collect their bib by presenting a valid form of ID: passport, national ID card, NIE, or driving licence.
- ✿ **THIRD-PARTY COLLECTION PROTOCOL** If a bib is collected by an authorised representative, they must provide:
 - ✿ A signed authorisation letter from the registered athlete
 - ✿ The official QR code or a digital copy of the athlete's ID
- ✿ **STRICT COMPLIANCE POLICY** Bib collection will only be granted upon full verification of the required documentation. The organisation operates a zero-tolerance policy — no exceptions will be made under any circumstances. Participants are fully responsible for complying with these rules.
- ✿ **TECHNICAL SPECIFICATIONS OF THE BIB** Each athlete will receive a personal and non-transferable bib with an integrated timing chip. The bib must:
 - ✿ Remain visible on the front of the athlete's clothing throughout the event
 - ✿ Stay intact – not folded, cut, or altered in any way
 - ✿ Maintain full timing functionality at all times

AWARD CEREMONY

To honour those who demonstrate the extraordinary endurance required to conquer this extreme challenge,



prizes will be awarded to the top three finishers in each category and subcategory. The inclusive category is a special exception, where every courageous participant will be recognised for their determination.

Prizes are unique and non-transferable by category. If someone is to receive an award on behalf of a winner, this must be communicated and explicitly authorised by the organisation at least 30 minutes in advance. The award ceremony will take place on the same day as the race, starting at 16:00, at the finish area in [Paseo Marítimo, Marbella](#), opposite the Plaza del Mar shopping centre, where we will celebrate the athletes who have proven their mental and physical strength.

For categories whose finalists do not reach the finish line before the start of the ceremony, their well-deserved awards will be available at the organisation table, strategically placed next to the finish line, awaiting these mountain warriors still battling their own limits.

PARTICIPATION STANDARDS

EQUIPMENT AND APPEARANCE

All athletes must wear their bib prominently on the front of their technical gear and use only equipment specifically designed for ultra-distance competitions. It is mandatory to carry a fully charged mobile phone, essential both for safety protocols and for race tracking

EXCLUSIVE ACCESS REQUIREMENTS

-  **Physical Condition:** This race is reserved for athletes with exceptional physical conditioning and the necessary experience to take on the extreme demands of the selected course.
-  **Athlete Profile:** Access is limited to ultra-distance runners who have either:
 - ✓ Completed at least one mountain race with a minimum positive elevation gain of 4,500m,
 - ✓ Or achieved finisher status in the legendary Sierra Blanca DESTROYER race (or an equivalent event).

MEDICAL CERTIFICATE

Submission of a valid **medical certificate (dated within the past 6 months)** is strictly required. Failure to provide this documentation will result in denial of participation without the right to a refund.

COMPETITION REGULATIONS AND SANCTIONS

Compliance with these rules is essential to maintain the integrity of the competition. The Mountain Running Regulations of the Andalusian Federation of Mountain Sports, Climbing and Hiking (FADMES) will be strictly enforced.

ART. 35.- PENALTIES OR DISQUALIFICATION OF AN ATHLETE OR TEAM

The following sanctions Will apply if a competitor commits any of the listed infractions:

-  **Deviating from the official course to gain an advantage** = 3-minute penalty to disqualification
-  **Receiving unauthorised assistance outside designated zones (except medical aid)** = 3-minute penalty to disqualification
-  **Littering on the course (including organic waste such as fruit peels, which can disrupt soil pH in ecosystems where such fruits do not occur naturally)** = 3-minute penalty to disqualification
-  **Intentionally obstructing another competitor** = 3-minute penalty to disqualification
-  **Lacking required equipment at official checkpoints** = 3-minute penalty to disqualification
-  **Disobeying instructions from organisers or referees** = 3-minute penalty to disqualification
-  **Tampering with or refusing to wear the race bib** = disqualification
-  **Altering official race markings or organisational equipment** = disqualification
-  **Repeated false start (second offence)** = disqualification
-  **Substituting mandatory equipment provided by the organisers** = disqualification.

ART. 36.- DISQUALIFICATION WITH POSSIBLE ADDITIONAL SANCTIONS

The following conduct Will result in immediate disqualification and may lead to further disciplinary action:



- Serious sportsmanship incident (e.g. aggression or verbal abuse towards competitors, organisers, referees or spectators)
- Deliberately causing an accident
- Testing positive in an anti-doping test
- Competing with someone else's race bib.

ADDITIONAL ORGANISATIONAL PROTOCOLS

Drinking directly from containers intended for refilling individual bottles at aid stations is strictly prohibited. This violation will result in immediate disqualification.

ATHLETE CODE OF CONDUCT

- Respect for the Environment:** Competitors must strictly follow the marked route and respect the natural environment. Respect for fellow athletes and the ecosystem is a core value of this competition.
- Absolute Restrictions:** The use of support vehicles, the presence of animals, and any external assistance or aid outside officially designated points is strictly forbidden.
- Control System:** All participants must pass through official checkpoints and use only the timing chip system provided by the organisation.

Failure to comply with these regulations may result in penalty and/or disqualification, thereby safeguarding the excellence and integrity that define the competition.

COMPLAINTS PROTOCOL AND APPEALS SYSTEM

ART. 40.- COMPLAINT PROCEDURE

40.1. All complaints must be submitted in writing to the Competition Technical Committee using the official form annexed to the regulations, along with the fee established by FADMES during the General Assembly. This amount will be refunded if the complaint is upheld. Each complaint must include the specific details outlined in the FADMES regulations, page 54.

40.2. Objections regarding provisional classifications may only be submitted within 30 minutes of their official publication.

ORGANISATIONAL APPEALS PROTOCOL

Complaints relating to the organisation of the event must be submitted exclusively via email to reclamaciones@cdutsb.org within a **strict deadline of 48 hours after the event**.

Complaints submitted through alternative channels will not be considered. Resolutions will be communicated within two months of the conclusion of the event, ensuring a thorough and fair review process.

IMAGE RIGHTS AND AUDIOVISUAL MATERIAL

Authorisation for Recording

The organisation reserves the exclusive right to film, document, and collect audiovisual and informational material during the course of the competition, which may include all participating athletes.

Promotional Use Licence

All audiovisual material may be used at the organisation's discretion for event promotion, institutional relations, media communications, and sports marketing campaigns related to this exclusive competition.

External Use Protocols

Use of this material in external media or advertising projects requires prior written authorisation from the organisation to ensure control over the event's image and reputation.

MODIFICATIONS AND EXCEPTIONAL CONDITIONS

**Right to Amend Regulations**

The organisation reserves the right to modify these regulations should significant or unforeseen circumstances arise. All updates will be communicated officially via certified email and institutional social media channels. It is the sole responsibility of each athlete to stay informed of such official communications.

Force Majeure Protocol

In cases of force majeure — including, but not limited to, extreme weather conditions (thunderstorms, heavy rain, high winds), wildfires, official health restrictions, road closures, or any other circumstances beyond the organisers' control — the event may be suspended, modified, or cancelled without entitlement to any financial compensation.

Severe Weather Alert Protocol

In the event of an official orange alert declared by the competent authorities, the competition will be automatically cancelled for safety reasons. This cancellation does not entitle participants to a refund, as the safety of all athletes takes absolute priority.
