Registration for the Marbella Epic Trail (MET) race entails full acceptance of this document, as well as the official rules of the event, available at: marbellaepictrail.com.

By completing their registration, the participant declares that they:

- Know, understand and fully accept the rules of the Marbella Epic Trail (MET) event, in any of its distances, which will take place within the municipal areas of Marbella, Ojén, Monda and Istán (Málaga).
- Are in adequate physical condition to take part in the competition, in good health, and do not suffer from any illness, medical condition or injury that could be aggravated as a result of their participation, undertaking to provide the medical certificate required by the organisation.
- Are fully aware that participation in this type of sporting activity, carried out in a natural environment and under variable conditions, involves inherent risks, and therefore take part voluntarily, fully assuming such risks.
- Acknowledge that, although the submission of a medical certificate is not mandatory, it is recommended to undergo medical check-ups or tests prior to participation, to ensure their fitness for the sporting activity.
- Authorise the event's medical team to carry out any health interventions they consider necessary during the race, even when it is not possible to obtain their consent at that moment and accept their withdrawal from the competition if the medical team deems it appropriate for health or safety reasons.
- Take part under their sole responsibility, expressly releasing the organisation, volunteers, collaborators, sponsors and other participants from any liability for physical or material damage that may arise from their participation, waiving any claim or legal action against them.

Registration for the event entails the express acceptance of this document.

Sierra Blanca Events Group SL is the controller of your personal data and informs you that they will be processed in accordance with Regulation (EU) 2016/679, of 27 April (GDPR), and Organic Law 3/2018, of 5 December (LOPDGDD), with the consent of the data subject's legal representative, the purpose of the processing being the running of leisure and training activities. Your data will be retained for no longer than is necessary to fulfil the purpose of the processing and will not be shared with third parties without your consent, except with the medical personnel taking part in the events/activities organised by the controller, in order to attend to any medical emergencies that may arise as quickly as possible and in a personalised manner, taking into account the needs and allergies of each participant. They may also be shared where required by legal obligation.

Your rights: Right to withdraw this consent at any time. Right of access, rectification, portability and erasure of the data, and to restriction of or objection to the processing. Right to lodge a complaint with the Supervisory Authority (www.aepd.es) if you consider that the processing does not comply with the regulations in force.
