

AUTHORIZATION OF PERSONAL DATA USE

The undersigned, having received the relevant information from the Data Controller in accordance with Regulation (EU) 2016/679 (General Data Protection Regulation, GDPR), hereby:

- 1. **Authorizes** the processing of their personal data for the purposes outlined in the provided information notice, except where processing is permitted without consent under Article 6 of GDPR and Portuguese Law No. 58/2019.

1. Purposes of Data Processing
